Hasil *assessment* periode tahun 2022 mencapai total skor 92,62 dari total bobot sebesar 100,00 dengan klasifikasi **"SANGAT BAIK"**, mengalami kenaikan dari tahun sebelumnya yang tercatat sebesar 83,66. Dari hasil penilaian tersebut, terdapat 10 rekomendasi pada *Area of Improvement* (AoI), yang perlu ditindaklanjuti sebagai upaya peningkatan kualitas penerapan governansi korporat di tahun selanjutnya.

Perusahaan berkomitmen untuk melakukan upaya tindak lanjut terhadap rekomendasi yang merupakan *Area of Improvement* (AoI) atas hasil *assessment* penerapan governansi korporat untuk tahun buku 2022, yang didasari dengan komitmen semua pihak terkait dalam rangka meningkatkan penerapan praktik governansi korporat dengan memperhatikan perkembangan terkini *best practice* yang berlaku.

ASSESSMENT GOVERNANSI KORPORAT TAHUN 2021

Guna mendukung penerapan governansi korporat, Perusahaan setiap tahunnya melaksanakan *assessment* governansi korporat. *Assessment* ini merupakan wujud komitmen seluruh pegawai dan manajemen IFG untuk senantiasa meningkatkan penerapan governansi korporat di lingkup Perusahaan.

The *assessment* results for the 2022 period reached a total score of 92.62 out of a total weight of 100.00 with the classification **"VERY GOOD"**, an increase from the previous year which was recorded at 83.66. From the results of this *assessment*, there are 10 recommendations for *Areas of Improvement* (AoI), which need to be followed up as an effort to improve the quality of corporate governance implementation in the following year.

The Company is committed to making follow-up efforts to recommendations which are *Areas of Improvement* (AoI) based on the results of the *assessment* of the implementation of corporate governance for the 2022 fiscal year, which is based on the commitment of all relevant parties in order to increase the implementation of corporate governance practices by taking into account the latest developments in applicable *best practices*.

CORPORATE GOVERNANCE ASSESSMENT 2021

In order to support the Corporate Governance Implementation, the Company annually carries out a Corporate Governance *assessment*. This Corporate Governance *assessment* is a form of commitment from all employees and management of IFG to continuously improve the implementation of Corporate Governance within the Company.
