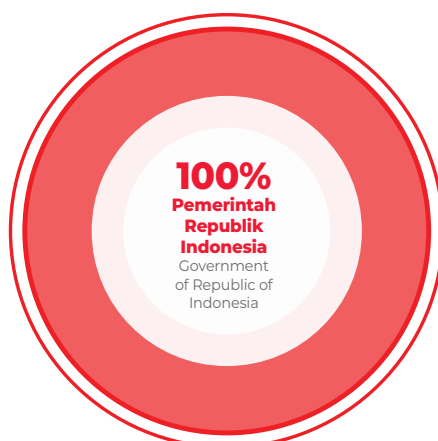

INFORMASI TENTANG PEMEGANG SAHAM UTAMA/PENGENDALI

Hingga akhir tahun 2024, sebanyak 93.719.537 lembar saham Perusahaan seluruhnya atau 100% dimiliki oleh Pemerintah Republik Indonesia yang berasal dari Penyertaan Modal Negara. Oleh karena itu, Pemerintah Republik Indonesia bertindak sebagai pemegang saham utama dan pengendali sekaligus pemilik akhir dari Perusahaan.

Berdasarkan PP No. 41 Tahun 2003 tentang Pelimpahan Kedudukan, Tugas dan Kewenangan Menteri Keuangan pada Perusahaan Persero (Persero), Perusahaan Umum (PERUM) dan Perusahaan Jawatan (PERJAN) kepada Menteri Negara Badan Usaha Milik Negara, dan UU No. 19 Tahun 2003 tentang Badan Usaha Milik Negara beserta Lembaran Negara Republik Indonesia; Kuasa Pemegang Saham Perusahaan adalah Kementerian BUMN.

INFORMATION ON MAJOR/CONTROLLING SHAREHOLDERS

As of the end of 2024, a total of 93,719,537 shares of the Company, representing 100% of the Company's total shares, are owned by the Government of the Republic of Indonesia through State Equity Participation. Therefore, the Government of the Republic of Indonesia acts as the majority shareholder and controller as well as the ultimate owner of the Company.

Based on PP No. 41 of 2003 concerning the Transfer of Position, Duties and Authority of the Minister of Finance in State-Owned Enterprises (Persero), Public Enterprises (PERUM) and Government Agencies (PERJAN) to the State Minister for State-Owned Enterprises, and Law No. 19 of 2003 concerning State-Owned Enterprises along with the State Gazette of the Republic of Indonesia; the Shareholder of the Company is the Ministry of State-Owned Enterprises.
