### Legal Basis of Establishment

1. Peraturan Pemerintah (PP) Republik Indonesia No.18 tahun 1973, tanggal 13 April 1973, tentang Penyertaan Modal Negara Republik Indonesia untuk Pendirian Perusahaan Perseroan dalam Bidang Pengembangan Usaha Swasta Nasional.
2. Akta No. 11 tanggal 17 April 1973, yang dibuat dihadapan Mohamad Ali, S.H., Notaris, di Jakarta, dan telah mendapat pengesahan dari Menteri Kehakiman Republik Indonesia tertanggal 22 Mei 1973 No. YA.5/191/20 dan telah diumumkan dalam Berita Negara Republik Indonesia No. 57 tanggal 17 Juli 1973 Tambahan Nomor 508.
1. Government Regulation of Republic of Indonesia No. 18 of 1973, dated April 13, 1973, concerning the Investment of State Equity of the Republic of Indonesia for the Establishment of a Company in the National Private Business Development.
2. Deed No. 11 dated April 17, 1973 drawn up before Mohamad Ali, S.H., Notary in Jakarta and has been approved by the Minister of Justice of the Republic of Indonesia dated May 22, 1973 No. YA.5/191/20 and has been announced in the State Gazette of the Republic of Indonesia No. 57 dated July 17, 1973 Supplement No. 508.

## Dasar Hukum Pembentukan Holding

### Legal Basis for the Establishment of Holding

1. PP No. 15 Tahun 2020 tentang Perubahan atas PP No. 18 Tahun 1973 tentang Penyertaan Modal Negara Republik Indonesia untuk Pendirian Perusahaan Perseroan dalam Bidang Pengembangan Usaha Swasta Nasional maksud dan tujuan dari IFG adalah untuk melaksanakan kegiatan sebagai perusahaan *Holding* di bidang keuangan dan investasi serta konsultasi manajemen untuk kepentingan perusahaan afiliasi atau pihak lain termasuk UMKM, dan optimalisasi pemanfaatan sumber daya Perusahaan Perseroan (Persero) berdasarkan prinsip tata kelola perusahaan yang baik.
2. PP No. 20 Tahun 2020 tanggal 16 Maret 2020 tentang Penambahan Penyertaan Modal Negara Republik Indonesia ke dalam Modal Saham Indonesia Financial Group, yang berasal dari pengalihan seluruh saham Seri B milik Negara Republik Indonesia pada Perusahaan Perseroan (Persero) Askrindo, Perusahaan Perseroan (Persero) Jasindo, Perusahaan Perseroan (Persero) Jasa Raharja, dan Perusahaan Perseroan (Persero) Jamkrindo.
1. Government Regulation No. 15 of 2020 concerning Amendments to Government Regulation No. 18 of 1973 concerning State Equity Participation of the Republic of Indonesia for the Establishment of a Company in the Field of National Private Business Development, the purpose and objective of IFG is to carry out activities as a Holding company in the field of finance and investment as well as management consulting for the benefit of affiliated companies or other parties including micro, small and medium enterprises (UMKM), and optimizing the utilization of the Company's (Persero) resources based on the principles of good corporate governance.
2. Government Regulation No. 20 of 2020 dated March 16, 2020 concerning the Addition of State Equity Participation of the Republic of Indonesia into the Share Capital of Indonesia Financial Group, derived from the transfer of all Series B shares owned by the Republic of Indonesia in Askrindo (Persero), Jasindo (Persero), Jasa Raharja (Persero), and Jamkrindo (Persero).
